MEMORANDUM FOR THE ANTIQUITIES ADVISORY BOARD

ASSESSMENT OF HISTORIC BUILDINGS

PURPOSE

This paper invites Members to consider confirming the grading of the buildings as detailed in paragraphs 3 and 4 and to consider the proposed grading of the buildings set out in paragraph 7 below.

BACKGROUND

- 2. As at the meeting held on 16 September 2014, Members have endorsed the grading of 1 299 buildings as set out below
 - (a) 169 buildings with Grade 1 status;
 - (b) 347 buildings with Grade 2 status;
 - (c) 478 buildings with Grade 3 status;
 - (d) 287 buildings with no grading; and
 - (e) 18 buildings with no further processing due to their demolition or substantial alteration.

ITEMS FOR CONSIDERATION

- 3. At the meeting held on 16 September 2014, Members accorded proposed grading to 8 new items and started the one-month public consultation. During the consultation period, no adverse comment has been received for 5 items. Members may wish to confirm the grading of these 5 items listed at **Annex A**.
- 4. For the remaining 3 new items as listed at **Annex B**, there are objections from the owner of Sai Kung Lok Yuk Kindergarten, No. 19E Po Tung Road, Sai Kung to the grading proposal. The Antiquities and

Monuments Office (AMO) also received objections from both the owners of No. 86 and No. 88 Stanley Main Street, Stanley and a member of the public to the grading proposal. AMO will further discuss with the owners of Sai Kung Lok Yuk Kindergarten, No. 19E Po Tung Road, Sai Kung and Nos. 86 and 88 Stanley Main Street respectively to address their concerns.

- 5. As regards the proposed grading of No. 118 Wellington Street, Central, a member of the public has suggested preserving in-situ the balconies with calligraphy. Another member of the public commented that No. 118 Wellington Street does not deserve the Grade 3 status, while the Central and Western Concern Group expressed strong support to preserve the shophouse. After reviewing the suggestion, the Assessment Panel maintained their views that the building be recommended a Grade 3 status.
- 6. A full copy of the written submissions received by AMO was delivered to Members well before the meeting for their information and consideration of the grading of the items.
- 7. The Assessment Panel has further completed the heritage assessment and grading recommendations of 3 new items at Annex C. Following the usual practice, subject to Members' views, AMO will upload the information and the proposed grading of the new items to the website of the Antiquities Advisory Board (AAB) for a one-month public consultation. AMO will also write to the owners of the privately-owned items to inform them of the proposed grading. We shall report to Members on any information or views received for further consideration before finalising the grading of these items.

ADVICE SOUGHT

8. Members are invited to consider confirming the grading of those items as detailed in pargraphs 3 and 4 above and endorsing the proposed grading of the new items mentioned in paragrah 7 above.
