MEMORANDUM FOR THE ANTIQUITIES ADVISORY BOARD

HERITAGE IMPACT ASSESSMENT IN RESPECT OF THE REVITALISATION OF THE FORMER LAU FAU SHAN POLICE STATION

PURPOSE

This paper seeks Members' views on the findings of the Heritage Impact Assessment ("HIA") in respect of the revitalisation of the Former Lau Fau Shan Police Station ("FLFSPS") in Yuen Long, New Territories.

HERITAGE IMPACT ASSESSMENT MECHANISM

2. The HIA in respect of the revitalisation of the FLFSPS was conducted in accordance with the HIA mechanism introduced by the Development Bureau ("DEVB") vide Technical Circular (Works) No. 6/2009. Since its implementation in 2008, the HIA mechanism for capital works projects emphasises that every effort should be made to avoid or minimise adverse impact on "heritage sites". In the submission to the Public Works Subcommittee of the Legislative Council, the works agent is required to include a "Heritage Implications" paragraph to be cleared by the Antiquities and Monuments Office ("AMO"), stating clearly whether the project will affect any "heritage sites" and if so, the necessary mitigation measures, as endorsed by the Antiquities Advisory Board, to be implemented.

THE PROJECT

- 3. The revitalisation of the FLFSPS is one of the projects under Batch V of the Revitalising Historic Buildings Through Partnership Scheme (the "Revitalisation Scheme") run by DEVB. The Revitalisation Scheme invites non-profit-making organisations with charitable status under section 88 of the Inland Revenue Ordinance (Cap. 112) to apply for the adaptive re-use of selected government-owned historic buildings in the form of social enterprises.
- 4. Batch V of the Revitalisation Scheme was launched in November 2016 and the selection results were announced in July 2018. Approval-in-principle has been granted by the Secretary for Development to Hong Kong Guide Dogs Association Limited to convert the FLFSPS into "Former Lau Fau Shan Police Station Hong Kong Guide Dogs Academy" ("The Academy") for guide dogs breeding and training for visually impaired people in Hong Kong, and to train service dogs to provide outreach services for people in need, such as children who suffer from autism and communicational problems etc. The Academy will also promote public understanding towards the architectural merits and cultural significance of FLFSPS, the history of Lau Fau Shan area and the guide dogs service through organising exhibitions and guided tours.
- 5. Given that the FLFSPS is a Grade 3 historic building which is of some heritage merit, AMO confirmed that an HIA would be required for the revitalisation works. Hong Kong Guide Dogs Academy Limited, the entity set up to take forward the project, has subsequently commissioned a heritage consultant to conduct the HIA.

HERITAGE IMPACT ASSESSMENT

- 6. The purpose of the HIA is to prepare a Conservation Management Plan with a set of heritage impact assessments which aims at designing mitigation measures to avoid adverse impact on the FLFSPS in the course of the revitalisation works and outlining the future interpretation, maintenance and management strategies.
- 7. Hong Kong Guide Dogs Academy Limited has submitted the HIA report based on AMO's Conservation Guidelines laid down in the Resource Kit for

Batch V of the Revitalisation Scheme to AMO for consideration. Given that the

character defining elements of the FLFSPS will be repaired as necessary and preserved as far as practicable and the likely impact on the structures will be kept

to a minimum through the proposed mitigation measures, AMO, therefore,

considers the proposal agreeable from the heritage conservation perspective and

is satisfied with the recommended mitigation measures. The salient points of the

HIA report and AMO's comments are set out in **Annexes A and B** respectively.
