1 0	● The CPS Compound, i.e. the CPS, the Central Magistracy and the Victoria Prison, is a fine example of Victorian and Edwardian colonial architecture in Hong Kong and were declared monuments in 1995.	<ul> <li>The revitalised CPS Compound commenced operation as "Tai Kwun – Centre for Heritage and Arts" on 29 May 2018.</li> <li>The Married Inspectors' Quarters (i.e. Block 4) in the CPS Compound partially collapsed on 29 May 2016. The Hong Kong Jockey Club ("HKJC") had explored and presented to the Antiquities Advisory Board (the "Board") proposed recovery plans of Block 4. In 2021, according to the findings of a building re-appraisal that the building structure of Block 4 was weaker than anticipated, HKJC terminated the recovery plans. In December 2022, for public safety's sake, HKJC updated the Board on its plan to remove unsafe portion of Block 4. The Board noted the removal works, and HKJC would explore and develop the Block 4's revitalisation scheme during the removal works. In September 2024, HKJC briefed the Board about the revitalisation scheme with latest status of the building and proposed reuse of the Block 4 site.</li> <li>In response to letters to the Board on HKJC's revitalisation scheme from the Hong Kong Institute of Architects and the Hong Kong Institute of Architectural Conservationists, HKJC met the two professional institutes in November and December 2024 for engagement about the revitalisation scheme.</li> <li>HKJC commenced preparatory works for revitalisation of the Block 4 site based on the revitalisation scheme presented to the</li> </ul>

The West Wing, completed in 1959, was used as government offices for over 50 years until 2011.	• Subsequent to the endorsement of the Heritage Impact Assessment ("HIA") report on the renovation of CGO West Wing by the Board on 4 March 2015, the conservation works to convert the building into the offices of the Department of Justice and law-related organisations commenced in October 2016 and were substantially completed, with the heritage interpretation works targeting for completion in 2025-26.
Revitalisation of Roberts Block, Old Victoria Barracks (Batch V)	• Roberts Block, a Grade 1 historic building, was built in the early 1900s and was originally known as army Married Quarters "E Block".	• Roberts Block is being revitalised by Christian Oi Hip Fellowship Limited into "Roberts Block Creative Arts Therapy Centre". The revitalisation works commenced in March 2022. Phase 1 of the works were substantially completed in the 3 <sup>rd</sup> quarter of 2025 and Phase 2 is targeted for completion in the second half of 2026.

HD proposed to reinstate the Hangar and Pillbox within the water feature park in the western part of the Diamond Hill CDA (not at the original locations). HD proposed adaptive reuse of the Hangar and Pillbox which would be on display with interpretation in the park after completion.</li> <li>Under the requirements of the approved EIA, AMO continues to provide technical advice from the heritage conservation perspective.</li> <li>HD submitted a restoration proposal of the Old Pillbox on 16 May 2022. AMO provided comment on the restoration proposal in October 2022. Permanent relocation of the Old Pillbox was carried out in March 2023 and final record was received in May 2023.</li> <li>HD submitted a final display and exhibit proposal for the Former Royal Air Force Hangar in June 2023, which allows visitors to view the Hangar in a close distance. The proposal is considered acceptable in view of structural integrity and future maintenance of the exhibit as well as public safety concern. The works were substantially completed in August 2024. Works were resumed in February 2019 and completed in December 2022.</li> <li>Phase 2 of the redevelopment commenced in July 2023. Works were partially suspended by HA due to uplift of TWM found on 12 July 2025. With implementation of remedial works, the uplift of TWM has been under control, with works resumed on 6 August 2025. Taking into consideration the above technical issues encountered under the two phases, HA has revised the overall target completion date of the project to 2027.</li> </ul>
